- No passport required, but must have official birth certificate
- Includes room, most meals, taxes, fees, and prepaid gratuities
- Sample items not included are sodas, adult beverages, spa treatments, gambling and expenses off the ship

Inside Cabin \$566 per person for the first two people
\$376 each additional person, sharing same cabin

Ocean View Cabin \$616 per person for the first two people
\$396 each additional person, sharing same cabin

Walt Disney World, Orlando Florida

- Disney package based on a minimum of two adults per room
- Disney requires you to be at least 18 to check in; those in the same room under 18 not related will require parental consent
- Base package includes only lodging in a standard Disney "Value" resort room and a 6 day Park Hopper ticket
- Sample items not included are meals, snacks and activities beyond four main theme parks like water parks, mini golf, etc.
